2024, with its multifaceted crises and challenges, confronts G20 leaders and many others with difficult choices on priorities and on their commitments and moral obligations. These challenges are set both within a global context where basic features of global governance architecture are in question, and at a very local level, and they are interconnected in ways that are increasingly forcing reassessment of approaches and institutional arrangements. economic, financial, and social legacies

of the COVID-19 pandemic accentuate challenges and have shone new light on global inequalities. Seasoned global leaders will reflect both on the challenges that confront G20 leaders today and religious perspectives on urgency and priority. The discussion will focus on the journey of interfaith and intrafaith networks and agendas. It will highlight the central importance of food security and its links to conflict and poverty, setting these challenges in the context of global financial systems and the immediate problems surrounding unsustainable debt and insufficient financial support, especially to the poorest communities.

While many would like to leave the COVID-19 emergencies behind, countries are contending with its legacies and the certain prospect that new pandemics will come. Meanwhile, other global health challenges demand attention, especially in cases where progress stalled during the response to the COVID-19 crises. Misinformation has been the basis for international incidents involving hate crimes, intolerance, and discrimination online and in person. In this session, the 2024 Report on Hatred on the Basis of Religion or Belief by the Special Rapporteur on FoRB, the UN Resolutions on Combating Intolerance, and the Rabat Plan of Action will be discussed. These documents give guidelines on dealing with negative stereotyping, discrimination, and incitement to violence against persons based on religion or belief. The world is in turmoil. While nearly half of the world's wealth is held by the richest one percent, 1.1 billion people, nearly 20% of the world population, live in acute multidimensional poverty across 110 countries. There are far over 100 armed conflicts and more than 100 million refugees worldwide. The rates of depression, stress, burnout and loneliness are globally on the rise. Against this backdrop, this session offers space for often neglected holistic concepts of development and prosperity, drawing from Indigenous, spiritual, and religious traditions. Participants discuss the implications of transitioning from linear worldviews and economic models centered on growth to cyclic understandings. Panelists share alternative ideas of measuring development and prosperity that are based on the well-being of nature, humans, and animals (Global Well-being Index) and propose policy recommendations for the (post) 2030 Agenda/SDGs and G20 discussions.

#### **D4. Global Reforms of Taxation**......Room N

In recent decades, large inequalities between the richest individuals and companies and the poorest citizens and legal entities have drawn increasing attention. Inequality is a pervasive global issue that needs to be addressed multilaterally and holistically. To take an example, in countries including Brazil, France, Italy, the UK, and the US, the super-rich pay an effective tax rate lower than the average worker. Tax-related Illicit Financial Flows (IFFs) and international tax competition compound inequalities. Taxation is an essential instrument to wealth redistribution among citizens to ensure their wellbeing. In line with the UN Sustainable Development Goals (SDGs) it can promote human dignity, equality, and prosperity, protect the planet from degradation, and foster peaceful, just, and inclusive societies, focused on the needs of the poorest and most vulnerable. This session will lead with a "Conversation on Inequality", where practitioners, civil society, and representatives from the UN and states will explore the landscape of international tax abuses and opportunities ahead, including negotiation of a UN Framework Convention on Tax Cooperation.

# **D6.** Indigenous Peacebuilding and Indigenous Religious Freedom for Building Sustainable Peace and Planet...Room H

Many of the world's 476 million Indigenous peoples in 90 countries and territories live in unstable areas, struggling to survive as conflicts, transnational organized criminal networks and extractive projects upend their lives and livelihoods. Their spiritual and religious traditions can help in healing people, peace, and planet. The panel will delve into how Indigenous traditions, governance, peacebuilding, and religious practices can help advance peace and resolve deadly conflict around the world.
